



# JWE Kid Connection 2021-2022

## WHAT IS KID CONNECTION?

JWE Kid Connection is an after-school program for enrolled children in 3rd through 5th grade. 3rd-5th Grade will take place at Jacob's Well Elementary so that students are in a familiar and safe environment. Experienced WISD employees supervise the children at all times. Students will be grouped according to age and participate in enjoyable enrichment activities. Our experienced staff is caring and creative and our students have fun each day.

## WHEN DOES IT OPERATE?

It is in session each full day of school. Hours are from afterschool-6:00 p.m. for \$130/month. JWE Kid Connection does not operate on school holidays, waiver days, half-days on yearly district calendar, or teacher in-service/workdays. In the event of an emergency closing, the parent/guardian will be expected to pick up the child when all other children are dismissed at their original campus as this is necessary to keep students safe.

## WHAT DO THE CHILDREN DO?

The children enjoy supervised classroom and recreational activities. Classroom activities will include enrichment and thematic activities revolving around literature and art. Recreation includes time to play on the playground and organized games. Children will also enjoy a snack together.

## HOW DO I ENROLL MY CHILD?

Complete this registration form and pay a one-time **non-refundable** \$50 registration fee (made payable to WISD). Forms may be picked up and turned in at Jacob's Well Elementary.

## DURING THE YEAR SAFETY EXPECTATIONS:

Your child will only be released to individuals on your list. If we do not know the individual, we will request to see the driver's license.

**PLAN AHEAD!** If a change is needed in after school routine, send a note to the homeroom teacher. If an emergency change is necessary, call the campus secretary and a note will be given to the child's teacher. *Please avoid frequent changes so your child will feel comfortable with his or her after school plans and routine.*

## WHAT ARE THE COSTS?

The **non-refundable** registration fee of \$50 due upon enrollment. There is also a one-time non-refundable snack fee of \$100 to cover the cost of snacks throughout the year. The fee for the program is \$130 per month. **The tuition fees are due on the 1st day of each month.** A late fee of \$20.00 will apply on the sixth day of the month. On the seventh day, the fee will increase to \$40. Full fee is due for Aug., Sept., Oct., Nov., Dec., Jan., Feb., Mar., Apr., and May. Program begins on the first day of school.

**How to Pay?** Checks made payable to WISD. Online at <https://wimberleyisd.revtrak.net>. The online system is set up by months. If you pay before the 1st of any month, it will automatically charge you the late fee. For example, if you pay May's tuition on April 28th, the system thinks you are paying for April and automatically charges the late fee.

**SNACKS-** Snacks will be purchased using the snack fee. Please provide medical information from your pediatrician regarding any food allergy or medical needs.

I, (we), the undersigned, have read and understand that: (Please check each statement below as you read and acknowledge). Kid Connection services are part of the Wimberley ISD and follow its policies.

- The Non-Refundable Registration Fee of \$50 is due at the time of registration. This guarantees your child a spot in the program.
- Fees are \$130 for the program payable to Wimberley ISD on the first school day of each month. A late fee of \$20 will apply (on the 6th day) of the month. On the 7th day, the late fee will increase to \$40. There is a one-time non-refundable snack fee of \$100 due with the August tuition. You may not skip a month of service without payment. For example, if your child does not attend in October, you will still owe for the month of October upon your return in November. We have a waiting list and we staff and continue to pay staff members to work regardless of whether your child is absent for a few weeks.
- Late fees will be assessed when parents pick up children beyond 6 pm. There will be a \$1.00 per minute/per child charge for late pick-up, which is payable at the time of pick-up. The clock in the JWE front office will be used to determine the fee amount.
- All children must be potty trained to attend JWE Kid Connection. After the first 2 weeks of enrollment, if we realize your child is not potty trained, we will un-enroll your child. Registration fee will not be refunded.
- Children who repeatedly have inappropriate behavior, hurt themselves, others, or property, or fees that are overdue will be subject to dismissal. We will keep track of both discipline and overdue fees. Parents will be informed of discipline issues. Students who have more than five discipline referrals are subject to dismissal from the program.
- Staff members will not release the child to anyone but the parent or persons with permission that are listed on this form or unless specific arrangements have been made.
